I, _____ the undersigned acknowledge and agree to the contract and terms listed below for services Black Diamond Luxury Transportation will provide. This contract will be on file and binding for all future services provided by Black Diamond Luxury Transportation to the undersigned.

REQUIREMENTS:

1. A valid credit card must be put on file at time of reservation. (See Credit Card Authorization Form)
2. 50% Deposit must be made at time of booking charged to the credit card.

LIABILITY AGREEMENT:

This agreement is a contractual arrangement with Black Diamond Luxury Transportation, for the hire of professional chauffeured services and pertains specifically to the performance by the customer in the vehicle during the course of time. In addition to the hourly rate for car & chauffeur, any damage in excess of usual wear of the hired car, there will be a minimum charge of \$300.00 for the repair and/ or general cleaning of the vehicle. Decision as to the usual wear and use of the vehicle interior and its environs rests with Black Diamond Luxury Transportation, solely, and their experience as to general habitation of hired vehicles and their decision is final. Nonrefundable deposit (50%) for cancellations within 30 days, cancellation within 14 days is non-refundable up to the entire amount. Substitution of vehicle is at the discretion of Black Diamond Luxury Transportation. Declined Credit Cards will incur a \$25.00 Fee plus all charges.

UNDER AGED "MINORS" OCCUPANTS:

Any person(s) under the legal age of drinking set by the State in which the reservation is taking place are not permitted to consume alcohol at anytime within the hired service time. We will cancel the reservation and take appropriate action if: Any minor is caught drinking, using illegal drugs, possession of any weapons or illegal self defense items during the time of hired service within the vehicle or outside the vehicle. Any vandalism to the vehicle or outside properties or any unlawful acts by any person within the vehicle will either be: 1. Returned to the original pick-up location. 2. We will call a parent to come and get the minor. 3. We will call the authorities and have the police resolved the situation. At that point the charter is then over and all persons will be returned to the destination noted on the reservation or they will be brought back to the pick-up location. All applicable fees will be charged to the credit card on file in full. Our chauffeurs will follow the directions from only the acting and legal guardian that is responsible for the reservation unless directed different in writing by that person. Only a preset route will be followed unless told different by acting legal guardian. Legal or acting guardian responsible for authorizing the reservation must be over 25 years of age with a valid credit card and legal I.D.

CHAUFFEUR:

Our chauffeurs will do everything possible to make sure you and your guests have the best of times. They will make your evening unforgettable. But please remember they are only chauffeurs and not butlers, they will carry your bags and belonging to your door and or to the car. They will also help anyone in and out of the car if asked and will make you forget about your transportation needs, but again please treat them accordingly. Please understand when we have minors in the car we cannot do anything but concentrate on our job so everybody gets to the destination safely. We cannot act as babysitters, disciplinarians or guardians. We simply ask to treat our chauffeurs with respect as our chauffeurs will defiantly treat you that way.
